815. WAR MEMORIAL

The remaining monies from the Diamond Jubillee fund have been offered, and the clerk has managed to obtain a grant of £300 from the LCC Parish Champion.

It was decided to have an unveiling of the memorial. Aldwyth Pearson to be contacted to see if this can be coincided with her plans for the commemorate WW1 weekend in November.
